Measure B will Destroy our small town quality of life and put the safety of all Butte County residents at risk.

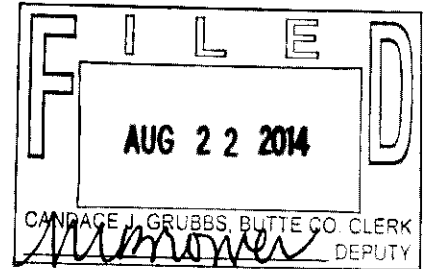

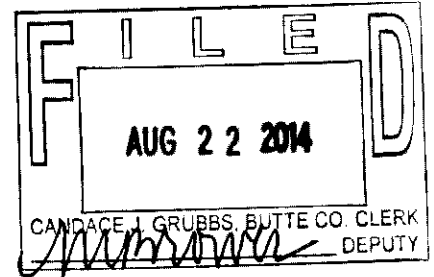

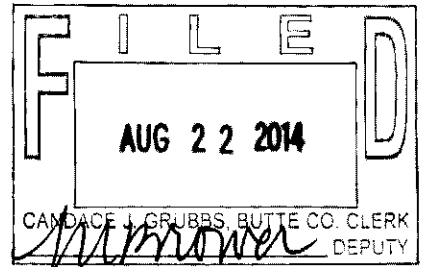
